

## FREEDOM HS PARKING POLICY

- 1. In order to purchase a hanger for the current school year, the student must be a Senior or Junior currently enrolled at Freedom HS, the student must have a minimum unweighted 2.0 GPA, and must be cleared of ALL obligations.
- 2. The parking hanger must be displayed on the vehicles rearview mirror at all times while on campus.
- 3. Students are only allowed to park in the designated student parking lot in their designated parking space. No Exceptions. Students parking in a space not assigned to them, parking in an unauthorized area, or who do not move their vehicle at the time designated will forfeit their hanger and are subject to towing.
- 4. The hangers are non-transferable, and therefore, the student is not allowed to give, to loan, or sell his/her parking hanger to another student. Doing so will result in forfeiture of the hanger.
- 5. Students must leave their cars immediately upon parking on campus. No sitting/waiting in vehicles allowed.
- 6. The administration has the right to revoke parking privileges for violation of school or district policy, including unexcused and/or excessive absences or tardiness.
- 7. Vehicles are not lockers. You will not be able to access books or materials stored in your vehicle during the day.
- 8. No parking allowed on sidewalks, or in spaces marked RESERVED/VISITORS. No parking on curbs or any grassy areas.
- 9. The student must follow the state, county, and city driving laws, including reporting accidents, following the posted speed limit, etc. Failure to follow driving laws will result in immediate suspension of students the parking privilege.
- 10. The speed limit for the parking lot is 5 mph. Reckless or dangerous driving will result in revocation of parking privileges.
- 11. HANGERS ARE NON REFUNDABLE.
- 12. Report lost or stolen parking hangers to an FHS Administrator immediately. The cost of a replacement Hanger is \$15 and the student will not be allowed to park on campus until a replacement hanger is purchased.
- 13. If a student has to forfeit their parking hanger during the school year, Freedom HS will not refund the cost of purchase.

## PARKING VIOLATION ENFORCEMENT

- 1. First violation will result in a warning.
- 2. Second violation will result in a warning + will not be eligible for parking pass for semester.
- 3. Third violation will result in a vehicle being towed at owner's expense.

## OCPS CONSENT TO SEARCH WAIVER OF LIABILITY

- 1. I agree that it is a privilege, not a right, to have an OCPS/FHS student parking hanger and drive or park on an OCPS campus. I agree that I if I fail to comply with OCPS/FHS policy or the conditions contained in this application, OCPS/FHS has the right to immediately suspend or revoke my hanger and parking privilege.
- 2. I agree that the student parking hanger I am issued and the parking lot are the property of OCPS/FHS.
- 3. I hereby waive any expectation of privacy in ANY VEHICLE (and its contents) that I drive or park on an OCPS/FHS campus.
- 4. I give consent and authorize OCPS/FHS, its employees and agents, and any law enforcement officer of any agency located within the State of Florida, to open and search any vehicle and its contents that I drive or park on an OCPS/FHS campus at any time, without prior notice or additional consent and without my knowledge or presence. I specifically waive the provisions of Florida Statute 232.256 and consent to the use of animals, such as dogs, trained to detect weapons or drugs.
- 5. I understand that if I refuse to cooperate with the search of a vehicle pursuant to this agreement, OCPS/FHS may have that vehicle towed or removed from the school's campus at the owner's expense.
- 6. I agree that I am responsible for the contents of any vehicle I drive.

- 7. I agree that OCPS/FHS and its officers, agents or employees, and any and all law enforcement personnel shall not be responsible and are released from liability of any theft, loss or damage to my property or vehicles while on an OCPS/FHS campus.
- 8. I agree that OCPS/FHS, its employees and agents, and all law enforcement agencies are hereby released and held harmless from all liability, claims, or damages, connected in any way with the search of the vehicle while on an OCPS/FHS campus, or the removal of a vehicle as provided herein.
